4. Municipal Qualifying

Director Gay advised that Municipal Qualifying was held August 18, 19, and 20. She advised that the office conducted the qualifying for Turin, Haralson, Moreland, and Sharpsburg. Senoia, Newnan and Grantville conducted their own qualifying.

5. November 4, 2025, Election

Director Gay advised Advanced in Person (Early Voting) will start October 14, 2025. She also advised that the first day that Absentee by Mail ballots can be mailed is also October 14, 2025. The Election for Sharpsburg and Moreland will be cancelled due to only one candidate qualifying for each contest. These candidates will be deemed as voting for themselves; therefore, the Election is cancelled. However, these precincts will still be open due to the Public Service Commissioner Contest and Questions that will be on the ballot.

She advised that Haralson is in both Coweta County and Meriwether County and that Coweta will be conducting their municipal election. Palmetto and Chattahoochee Hills are in both Coweta County and Fulton County and Fulton will be conducting their municipal elections.

She advised that L&A (Logic and Accuracy Testing) will start on September 29, 2025, and continue until completed.
